

**CASCADE PRIME TIMERS
NEW MEMBER RELEASE AND WAIVER OF LIABILITY AGREEMENT**

1. The Cascade Prime Timers Ski Club ("CPT") is a year-round social and sports organization providing a variety of activities for its members. Most of the activities are, to a varying degree, hazardous. By making this application for membership, I voluntarily assume the risks involved.
2. IN EXCHANGE FOR THE OPPORTUNITY TO PARTICIPATE IN THE ACTIVITIES OF CPT, I HEREBY RELEASE FROM LIABILITY AND AGREE THAT I WILL NOT MAKE ANY CLAIM WHATSOEVER AGAINST CPT, ITS AGENTS, BOARD MEMBERS, OFFICERS, DIRECTORS, EMPLOYEES, TRIP LEADERS, VOLUNTEERS, AND SPONSORS.
3. THE CLAIMS THAT I AGREE NOT TO MAKE (THAT IS, TO RELEASE) ARE ALL CLAIMS FOR ANY AND ALL DAMAGES FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH (INCLUDING CLAIMS FOR ATTORNEY FEES AND COSTS), AGAINST CPT OR ANY OF THE PERSONS NAMED OR DESCRIBED IN PARAGRAPH 2, INCLUDING BUT NOT LIMITED TO CLAIMS BASED ON LIQUOR LIABILITY, THE NEGLIGENCE OF CPT OR ANY PERSON NAMED OR DESCRIBED IN PARAGRAPH 2, WHETHER THE CLAIMS ALREADY EXIST OR ARISE IN THE FUTURE, AND WHETHER THE CLAIMS ARISE FROM AN INHERENT RISK OR DANGER IN THE ACTIVITIES DESCRIBED IN PARAGRAPH 1 OR NOT, PROVIDED THAT THE CLAIMS RELATE DIRECTLY OR INDIRECTLY TO ANY OF THE FOLLOWING: (1) MY PARTICIPATION IN ANY CPT ACTIVITY, INCLUDING SOCIAL, ACTIVITIES; (2) MY TRAVEL TO OR FROM ANY SUCH ACTIVITY; OR (3) MY USE OF ANY PROPERTY, FACILITY OR EQUIPMENT OWNED, LEASED, CONTROLLED OR OPERATED BY CPT OR ANY OF THE PERSONS NAMED OR DESCRIBED IN THE PRIOR PARAGRAPH.
4. I also agree to DEFEND, INDEMNIFY AND HOLD HARMLESS any of the people or entities described in Paragraph 2 against any claim by any third party against them as a result of my participation in any of the activities described in Paragraph 3.
5. If any part of this Release is found unenforceable, the remaining parts shall still be enforceable. This release shall be binding upon my successors and assigns, heirs, next of kin, executors and administrators.
6. I authorize CPT to publish my name, address, telephone number, email address and other information in its print and online (members only) newsletters and directories.
7. I certify by signing below that I am over 21 years of age.

I HAVE CAREFULLY READ AND CLEARLY UNDERSTAND THIS RELEASE OF LIABILITY PRIOR TO SIGNING IT. I AM AWARE THAT BY SIGNING THIS RELEASE OF LIABILITY I AM WAIVING CERTAIN LEGAL RIGHTS, WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNEES MAY HAVE AGAINST CPT. I VOLUNTARILY SIGN THIS RELEASE AGREEMENT.
